

SECRETLAB WORLDS 2020: 'PRESTIGE' CHAIR CONTEST OFFICIAL RULES

30 SEPTEMBER 2020

THESE RULES WERE AMENDED ON 30 SEPTEMBER 2020 TO BRING FORWARD THE CONTEST EXPIRATION TIME TO 12:00:00 ON 31 October 2020, SINGAPORE TIME. ALL OF THE TERMS OF THE OFFICIAL RULES AS RELEASED ON 25 SEPTEMBER 2020 REMAIN UNCHANGED.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED TO PARTICIPATE.

IF THE GRAND PRIZE WINNER RESIDES OUTSIDE AUSTRALIA, CANADA, CHINA, EUROPEAN ECONOMIC AREA, INDONESIA, JAPAN, KOREA, MALAYSIA, NEW ZEALAND, THE PHILIPPINES, SINGAPORE, SWITZERLAND, THAILAND, UNITED KINGDOM OR THE UNITED STATES, THE PRIZE WINNER WILL NEED TO PAY THE COSTS OF PRIZE DELIVERY.

THE SPONSOR

This Secretlab Omega Worlds 2020 'Prestige' Chair Contest, or the **Contest**, is sponsored by us, **SECRETLAB SG PTE. LTD.** (Company Registration No. 201506443C), a Singapore company having its registered business address at 994 Bendemeer Road, #03-07 B Central, Singapore 339943, or the **Sponsor**.

THE CHALLENGE

The challenge involves collecting as many points as you can and coming up with the most creative response to the question, "Which team do you think will win Worlds and why?"

To enter the challenge, each participant in the Contest (each, an **Entrant**) must complete the following steps:

1. Register your entry through the Sponsor's online interface for the Contest, known as the **Gleam Widget**, which is located at <https://gleam.io/tE85B/secretlab-omega-worlds-2020-prestige-edition-contest>, or the **Contest Landing Page**.
2. At the Contest Landing Page, you must submit your name and email address through the Gleam Widget or by logging into the Gleam Widget using your Facebook or Twitter logins. When submitting your entry, please make sure that the e-mail address you provide is one that you check regularly. We are not responsible to any prize winner who forfeits a prize because of that individual's failure to respond to any prize notification and its instructions in a timely manner.
3. Only individuals who meet the age eligibility requirements and agree to comply with these Official Rules will be allowed to participate in the Contest.
4. Enter your response to the question, "Which team do you think will win Worlds and why?" (**Key Question**).
5. Collect points for completing the following **Actions** while you are **logged into the Gleam Widget**:
 - logging into the Gleam Widget;
 - answering the Key Question;
 - visiting the Sponsor's Facebook page;
 - visiting @secretlab on Instagram;
 - following @secretlabchairs on Twitter;
 - retweeting posts that we have specified on the Gleam Widget on Twitter;
 - referring the Contest to your friends (limited to one point regardless of the number of referrals you make);
 - submitting a picture of you picking your League of Legends®-themed set-up; and
 - completing all of the actions listed in the Gleam Widget.

The number of points awarded for each Action will be as designated in the Gleam Widget. You will not be able to collect points if you carry out any of the Actions while logged out of the Gleam Widget.

We will determine, at our sole discretion, whether your entry into the Contest, or an **Entry**, is successful. All Entries shall be the property of the Sponsor and will not be returned. You may not purchase, transfer, sell or exchange any Entry and doing so will void all your Entries. The Entries have no cash value and will expire at the end of the Contest Period.

Normal Internet or telephony access and usage charges imposed by your internet service provider or telephony service carrier may apply.

ENTRY PERIOD

You may enter the Contest beginning at 23:00:00 on 26 September 2020, Singapore Time, and ending at 12:00:00 on 31 October 2020, Singapore Time. The database clock used by the Glean Widget (defined below) will be the official timekeeper for the Contest.

JUDGING

Only properly submitted entries will qualify for judging. Entries are properly submitted only if: (a) they were submitted by a participant who meets the eligibility criteria described in these Official Rules (**Eligible Entrants**); and (b) the participant submitting the Entry provided an answer to the Key Question.

We will select the consolation prize and grand prize winners based on the creativity of the participants' responses to the Key Question, as judged by us.

We will have the sole authority and discretion to select the grand prize and consolation prize winners, and all decisions of the Sponsor shall be FINAL. By entering into this Contest, you agree to be bound by our decisions.

THE PRIZES

The grand prize winner will receive the following (with a total approximately retail value, or **ARV**, of USD449):

- One exclusive Worlds 2020 Lanyard; and
- One exclusive Worlds 2020 Keychain.

The consolation prize winners will each receive One exclusive Worlds 2020 Lanyard and one exclusive Worlds 2020 Keychain, with an ARV of USD60. We will be awarding 400 consolation prizes.

The ARV values may vary for participants from outside the United States.

Contest prizes are not transferable, assignable or redeemable for cash, and cannot be refunded, sold, bartered, substituted or exchanged.

We will announce the grand prize winner on the Contest Landing Page and the comment section of our Contest post on our social media pages by 23:00:00 Singapore Time on 2 November 2020. We will not be publicly announcing the names of the consolation prize winners. We will contact each of the prize winners privately via e-mail and/or direct messages through the winners' social media accounts.

To claim the prize, the winners must meet all of the following requirements (**Prize Collection Requirements**) within 30 days of Secretlab's notification:
